designermakers21 is a unique, co-operative project so a collaborative approach is expected.

As a full member you will be expected -

- To be working in your studio a minimum of three days a week (or equivalent hours).
- Because we are a retail outlet, open to the public on Thursday, Friday and Saturday, 10am to 5pm, all members are expected to be present Thursdays, Fridays and Saturdays as a minimum. We aim to negotiate flexible cover of each others absences when necessary.
- Attend group management meetings weekly/fortnightly or as required, usually, on Fridays at 4pm.
- Pay rent one month in arrears(?) at the end of each month. Rent is £75/month
- All members need to have their own PLI (a-n.co.uk Artist Newsletter provides goog PLI cover when you subscribe, at a very reasonable price. [https://www.a-n.co.uk/join\\_in/article/663847](https://www.a-n.co.uk/join_in/article/663847))
- As a member of designermakers21 you will be expected to fulfil roles involved with the running of the project:

Domestic day to day roles are shared.

Responsibilities for running and progressing designermakers21 are allocated as fairly as is possible. Some roles being solo and others are managed in small teams.

- Members of designermakers21 are, automatically, members of designermakersCIO.
